CLCR needs to determine our role in the Master Plan and the town with regard to opening up the lake to the community. Possible ideas, other than rowing, could be kayaks and standup paddle boards. A question to answer, how does CLCR support rowing on Coventry Lake for all local teams?

We will possibly need to call a special meeting to discuss a plan and CLCR's role.

Steve advised that he has been working on the spirit wear store and it is a work in progress. He will show Pam a draft of the store in the coming weeks.

## NEW BUSINESS:

Courtney advised that there is a local mom's group of pre-K - 3 year olds who is looking to do activities which possibly involves a learn row program. We could possibly do this a fundraiser for CLCR.
